

## E-Visa Requirements

---

### Azerbaijan E-Visa

- **Documents Required:** Scan 6 months valid Passport & Signature Page duly signed by the passport holder.
- **CNIC:** Scan Copy of CNIC front & back.
- **Processing Time:** 04 Working Days Require.
- **Application Fee:** 13,000/- PKR

### Malaysia E-Visa

- **Documents Required:** 9 Month Valid Passport (First page Scanned in PDF Format).
- **Photograph:** 1 photograph scanned, size 50x35mm (white Background, without glasses/ cap) in JPEG Format.
- **CNIC:** CNIC Copy.
- **Bank Statement:** Updated online 6 months Bank Statement with min PKR 200,000 Closing Balance (In PDF Format).
- **Processing Time:** 12-15 working days required for processing.
- **Application Fee:** 15,000/- PKR

### Turkey E-Visa

- **Documents Required:** Scan Copy of Passport at least six months valid.
- **NIC:** NIC Scan Copy.
- **Other:** Valid Uk Usa Schengen Visa Copy and Mother Name.
- **Consultancy Fee:** 100\$

### Sri Lanka E-Visa

- **Documents Required:** Scan 6 months valid Passport & Signature Page duly signed by the passport holder.
- **Processing Details:** Scan Copy of CNIC front & back, 04 Working Days Required.
- **Application Fee:** 10,500/- PKR

### Cambodia E-Visa

- **Documents Required:** Scan Copy of Passport at least six months valid and NIC Scan Copy.
- **Photograph:** 01 scan picture with any Background.
- **Processing Time:** 3 to 4 Days Required.
- **Application Fee:** 15,000/- PKR

### Thailand E-Visa

- **Documents Required:** 6 months valid Scan Passport and CNIC Copy.
- **Photograph:** 1 photograph, size \$34\times45\sim\text{mm}\$ (white Background, without glasses/cap).
- **Bank Statement:** Last 6 Months Bank Statement with Account Mentence Certificate.
- **Processing Time:** 7 to 08 Working Days required for processing.
- **Application Fee:** 17,500/- PKR

### Indonesia E-Visa

- **Documents Required:** Passport Scan copy, 1 Passport Size Photo (Scan Copy), CNIC Photo Copy, and Passport Signed Page.
  - **Processing Time:** 10 To 15 Working Days Required.
  - **Application Fee:** 29,000/- PKR

### Sticker Visa Requirements

---

#### Indonesia Sticker Visa

- **Documents Required:** 18 months valid Original Passport & Signature Page duly signed by the passport holder.
- **CNIC & Photos:** CNIC Copy and 4 photographs, size \$34\times45\sim\text{mm}\$ (white Background, without glasses/ cap).
- **Bank Statement:** Updated 6 months Bank statement duly stamped & signed from respective bank with Min PKR 200,000 Closing Balance.

- **Professional Docs:** 3-4 Covering Letter from Employer, Chamber of Commerce Certificate, and NTN (Compulsory).
- **Other Docs:** Family Registration Certificate (for family travelling), Marriage Registration Certificates (Spouse travelling), and Police clearance Certificate (Compulsory).
- **Processing Time:** 7-10 working days required for processing.
- **Application Fee:** 44,000/- PKR

### **Egypt Sticker Visa**

- **Documents Required:** One Fully, Correctly & Clearly, Completed Visa Application and Passport valid until at least 6months+ with photocopies of 1st 2pages.
- **Photos & Travel:** 2 passport-size photographs in white background, Confirm return air ticket/ Itinerary, and Hotel Reservation and Fax Intimation to the Embassy.
- **Financials:** Last 6months Bank statement with account maintenance letter, NTN Tax Return, and Chamber Membership Certificate.
- **Health & Business:** Request latter, Business Documents if you have, Dengue Test Report, and Polio Vaccination Certificate.
- **Application Fee:** 25,000/- PKR

### **Tajikistan Sticker Visa**

- **Documents Required:** Original Passport, Picture, and Id card copies.
- **Application Fee:** 46,000/- PKR

### **Uzbekistan Sticker Visa**

- **Documents Required:** Original Passport, Picture, Id card copies, and Last 6 Months Bank Statement with Sign & Stamp.
- **Application Fee:** 42,000/- PKR

### **Visa Consultancy Services**

---

### **Turkey Tourist Visa Consultancy**

- **Documents Required:** Passport (Valid with 6 months), Pictures (white background, size \$5cm+5cm\$), and Cover Letter (If businessman letterhead).
- **Income Proof:** Proof of income (Business registration certificates/employment letter & 3-month salary slips).
- **Other Docs:** Bank statement & Maintenance Certificate (last 3 months), NTN & Tax Returns (last 01 year), FRC, and Passport Copy.
- **Special Cases:** NOC for Government employees, Bonafide Letter for students, Pensioner proof for retirees, and Affidavit for sponsored applicants.
- **Processing:** 02 To 03 weeks required after submission.
- **Consultancy Fee:** 15,000/- PKR

### Canada Visa Consultancy

- **Documents Required:** Original Passport with 6-month Validity and signature. Copy of CNIC both side Cleared.
- **Financials:** Last Six Months Bank Statement along with account maintenance letter sign & stamp, NTN Number + Tax Return last two years.
- **Personal/Family:** Property Documents (Sale Deed), FRC or MRC, and Police Character Certificate (Not Compulsory).
- **Employment/Business:** Job Letter/Leave Sanction letter/Salary slips (if employed), or Business Documents/Company Letter Head (if self-employed).
- **Consultancy Fee:** 50,000/- PKR

### Schengen Countries Visa Consultancy

- **Employee Docs:** Salary Slip of Last 03 Months, 6 months bank statement, Leave permission, and ITR form.
- **Self-Employed Docs:** Business Letter, Business license copy, 6 months company bank statement, and NTN & ITR of Last 02 Years.
- **Other Categories:** Proof of enrollment & NOC for students, Pension statement for retirees.
- **Consultancy Fee:** 40,000/- PKR

### Japan Visa Consultancy

- **Documents Required:** Original Passport with 6-month Validity, 03 Pictures white background (\$35cm\times45cm\$), and Copy of CNIC.
- **Financial/Work:** Last Six Months Bank Statement, Job Letter & Salary slips (if employed), NTN + Tax Return last two years, and Chamber Membership Certificate.
- **Other Docs:** Polio Vaccination Certificate, FRC/MRC, and Affidavit confirming purpose/funds on stamp paper.
- **Consultancy Fee:** 30,000/- PKR

#### **Singapore Visa Application**

- **Documents Required:** Scan 6 months valid Passport, 1 Scan Picture in White Background (\$34\times45\sim mm\$), and Scan CNIC front & back.
- **Processing Time:** 10 to 15 working days required.
- **Application Fee:** 14,500/- PKR

#### **South Africa Visa Consultancy**

- **Documents Required:** Original Passport (6-month validity), 03 Pictures (\$35cm\times45cm\$), and CNIC Copy.
- **Work/Financial:** Bank Statement (6 months), Salary slips/Job Letter/Leave Sanction (if employed), and NTN + Tax Return (2 years).
- **Additional:** Polio Certificate, Chamber Recommendation, FRC/MRC, and Affidavit on stamp paper.
- **Consultancy Fee:** 25,000/- PKR

#### **United Kingdom Visa Consultancy**

- **Documents Required:** Original Passport (6-month validity), CNIC copy, and 6 months Bank Statement with maintenance letter.
- **Work/Business:** Salary slips/Job Letter (if employed), or Business Documents/Company Letter Head (if self-employed).
- **Tax/Family:** NTN + Tax Return (2 years), Property Documents, and FRC/MRC.
- **Consultancy Fee:** 55,000/- PKR

#### **U.S.A Visa Consultancy**

- **Documents Required:** Original Passport (6-month validity), Two Pictures (2x2 inches) with one soft copy, and CNIC copy.
- **Financial/Work:** 6 Months Bank Statement, Salary slips/Job Letter (if employed), CV (Curriculum Vitae), and Business Documents or Partnership deed.
- **Consultancy Fee:** 50,000/- PKR
